

## FOX NATION – REPUBLICAN PRESIDENTIAL DEBATE SWEEPSTAKES

### OFFICIAL RULES

**NO PURCHASE IS NECESSARY TO PARTICIPATE OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.**

**TO BE ELIGIBLE TO PARTICIPATE AND WIN A PRIZE (AS THAT TERM IS DEFINED BELOW), YOU MUST LIVE IN THE UNITED STATES OF AMERICA AND MUST SATISFY THE OTHER ELIGIBILITY REQUIREMENTS SET FORTH BELOW.**

**YOUR ENTRY IN THIS SWEEPSTAKES MEANS THESE OFFICIAL RULES FORM A BINDING LEGAL CONTRACT, SO READ THEM CAREFULLY BEFORE PARTICIPATING. WITHOUT LIMITATION, THIS CONTRACT PROVIDES FOR YOUR INDEMNIFICATION OF THE SPONSOR AND OTHER PARTIES, THE WAIVER OF THE RIGHTS TO PARTICIPATE IN A CLASS ACTION OR A JURY TRIAL, AND A REQUIREMENT THAT MOST DISPUTES WILL BE SETTLED BY MANDATORY BINDING ARBITRATION.**

**1) Sweepstakes Entry Period:** The FOX NATION – REPUBLICAN PRESIDENTIAL DEBATE Sweepstakes (the “Sweepstakes”) begins at 5 AM Central Time (“CT”) on August 3, 2023, and ends at 11:59 PM CT on August 6, 2023 (the “Sweepstakes Entry Period”).

**2) Eligibility:** To be eligible to enter the Sweepstakes and receive a Prize, Participants must, at the time of entry, meet all of the following requirements: (i) be legal residents of one of the fifty (50) United States or the District of Columbia (“Territory”); and (ii) be 18 years of age or older and the age of majority in the entrant’s jurisdiction as of the date and time of participation (each, a “Participant(s)”). Employees, officers, directors and agents of Fox News Network, LLC (“Fox News”), Fooji, Inc. (“Fooji,” “Sponsor” or “Administrator”), any other company involved in the presentation, administration or fulfillment of the Sweepstakes, and their respective subsidiaries, affiliated companies, and divisions (collectively, the “Sweepstakes Entities”) and each of their immediate family members (defined as any spouse, partner, parent, legal guardian, sibling, child, legal ward, grandparent, or grandchild, regardless of where they reside) and/or those living in the same household of any such person (whether or not related) are not eligible for the Sweepstakes. Void outside the Territory and where prohibited or restricted by law.

**3) Sponsor:** The Sponsor and Administrator of the Sweepstakes is Fooji, Inc. located at 257 E. Short St. Suite 200, Lexington, KY 40507.

**4) How To Participate in the Sweepstakes:** After the start of the Sweepstakes, during the Sweepstakes Entry Period, to participate, (i) access the online entry form at <https://foxdebatesweeps.com/> ii) complete the online entry form by providing your name, physical address, email address; (iii) agree to the terms and conditions of this Sweepstakes, including these Official Rules; and (iv) follow the prompts to submit the entry. Purported entry forms that are incorrect or incomplete, received outside the Sweepstakes Entry Period or that contain

obscene, offensive, or any other language communicating messages inconsistent with the positive images with which Sponsor wishes to associate itself (all as determined by Sponsor in its sole discretion) will be void and disqualified. Sponsor is not responsible for misspellings, typographical errors, or other issues that may affect the ability to locate or record a purported entry. Normal Internet access and phone/usage charges imposed by your online/phone service may apply. Each online entry form must be manually key stroked and manually entered by the individual Participant; automated and/or repetitive submission of online entry forms (including but not limited to entries made using any script, macro, bot or sweepstakes service) will be disqualified.

**NOTE ABOUT MOBILE DATA AND MESSAGING CHARGES:** When you participate in the Sweepstakes via a mobile device and/or download or transmit data via your mobile device, data and messaging rates may apply according to the terms and conditions of your service agreement with your wireless carrier. Other charges may apply (such as normal airtime and carrier charges) and may appear on your mobile phone bill or be deducted from your prepaid account balance. Wireless carriers' rate plans may vary, and you should contact your wireless carrier for more information on rate plans and charges relating to your participation in this Sweepstakes. Check your mobile device's capabilities for specific instructions.

**5) Prizes:** Nine (9) prize are available (each, a "Prize"), as detailed below. All federal, state and local taxes and all other expenses not expressly listed in these Official Rules are the sole responsibility of the verified Prize winners ("Verified Prize Winner(s)"). Prizes are non-transferable and may not be substituted or redeemed for cash by Verified Prize Winner(s). No more than the stated number of Prizes may be awarded. Gift cards are subject to their own terms and conditions. Sponsor reserves the right to substitute any Prize for one of comparable or greater value. Prize type(s) and components will be selected by Sponsor or its representatives in its/their sole discretion. Actual retail value of the Prize may vary, including variations based on the Participants' location. All expenses and costs not expressly listed in these Official Rules are the sole responsibility of the Verified Prize Winner(s). Verified Prize Winner(s) will be responsible for all other expenses relating to the receipt and use of the Prize. All travel-related and other expenses not set forth herein, including but not limited to meals, ground and other transportation, parking, gratuities and incidental hotel expenses, are the sole responsibility of Verified Prize Winner(s).

Each Prize is a trip for two (2) (Verified Prize Winner and his/her guest) to attend the 2023 Republican Presidential Debate on August 23, 2023, in Milwaukee, WI presented by Fox Nation. Each Prize shall be comprised of:

- Roundtrip coach airfare for Verified Prize Winner and his/her guest within the United States to Milwaukee, Wisconsin from/to closest major U.S. airport to the Verified Prize Winner's residence;
- one (1) night hotel accommodation, twin share, at a 4 star hotel in Milwaukee, Wisconsin; and

- two (2) tickets to the Republican Presidential Debate; and car service from the airport to the hotel, hotel to the debate, and from the hotel back to the airport.

The total approximate retail value of each Prize is **\$3,050**.

The total approximate retail value of all Prizes available in this Sweepstakes is **\$27,450**.

**6) Winner Selection:** Odds of winning a Prize in this Sweepstakes depends on the number of entries received during the Sweepstakes Entry Period. Fooji will be the official time keeper for the Sweepstakes and all decisions by the Administrator regarding the timing of entries and the order in which they are received will be final and binding. Subject to compliance with these Official Rules, on or about August 7, 2023, Administrator will select nine (9) potential Prize winners ("Potential Prize Winner(s)") in a random drawing from all eligible and verified Participants who submitted an online entry form during the Sweepstakes Entry Period.

If you are chosen as a Potential Prize Winner, you will receive a notification from the Administrator via email indicating that you are a Potential Prize Winner. Within seventy-two (72) hours after that notification is sent, the Potential Prize Winner(s) and his or her guest will be required to execute an Affidavit of Eligibility, a Liability Release, a background check authorization form (including a criminal background investigation), and (where imposing such condition is legal) a Publicity Release (collectively, "Prize Claim Documents"). If the Potential Prize Winner(s) fails or refuses to sign and return all Prize Claim Documents within the period of time specified in the prize notification, the Potential Prize Winner(s) may be disqualified, in which case his or her guest will also be disqualified. Please note that each Potential Prize Winner(s) and his or her guest will be subject to a background check to comply with security protocols established for the debate, confirm eligibility and help ensure that the attendance of any such person at the debate will not bring the Sweepstakes Entities into public disrepute, contempt, scandal or ridicule or reflect unfavorably on the Sweepstakes Entities or the debate as determined by Sponsor in its sole discretion. In addition, based on the background check of the Potential Prize Winner(s) or his or her guest, Sponsor may in its sole discretion disqualify such person(s) from attending the debate and receiving the Prize. Subject to the foregoing the Potential Prize Winner(s) will be declared Verified Prize Winner of the Sweepstakes.

Airports are chosen by Sponsor in its sole discretion. Seats on any desired flight are not guaranteed. Verified Prize Winner(s) and his/her guest must commence and complete the trip by the dates specified by Sponsor (exclusions/blackout dates may apply). Verified Prize Winner(s) and his/her guest must travel on the same itinerary. If Verified Prize Winner(s) is unable to travel on the dates booked and/or provided by Sponsor, then the Prize will be forfeited and selected winner will not receive any additional prize. All travel-related and other expenses not set forth herein, including but not limited to meals, ground and other transportation, parking, gratuities and incidental hotel expenses, are Verified Prize Winner(s)'s sole responsibility. Verified Prize Winner(s) is responsible for all transportation, tax, license, title fees and insurance for transportation and other related, applicable expenses. Both Potential Prize Winner(s) and his/her

potential guest must be 18 years or older. Verified Prize Winner(s) and his/her guest are responsible for obtaining all required travel documents, and compliance with any health restrictions. Verified Prize Winner(s) his/her guest must have valid government-issued photo identification at the time of travel. Sponsor may run a background check on Potential Prize Winner(s) and his/her guest. While engaging in any Prize-related activities, Verified Prize Winner(s) and his/her guest must follow all applicable government recommendations and guidelines with respect to Coronavirus/COVID-19. In the event the Verified Prize Winner(s) and/or his or her travel companion/s engages in behavior that, as determined by Sponsor in its sole discretion, is obnoxious or threatening, illegal or that is intended to annoy, abuse, threaten or harass any other person, Sponsor reserves the right to terminate the trip or other applicable experience early, in whole or in part, and send the Prize winner and/or his or her travel companion/s home with no further compensation.

Participants selected as winners are limited to one (1) Prize per person, per delivery address during the Sweepstakes Entry Period. Unless the Sponsor elects to provide the cash equivalent of the Prize in lieu of the Prize described herein as determined by Sponsor in its sole discretion, no substitution of any Prize is offered, no transfer of Prize to a third party is permitted, and non-cash Prize(s) may not be redeemed for cash value. Verified Prize Winner(s) will be solely responsible for all applicable federal, state and local taxes on Prize(s) and may receive an IRS Form 1099 for the retail value of the Prize. If requested, Verified Prize Winner(s) must provide Sponsor with a valid social security number for tax reporting purposes. All expenses associated with the receipt and use of a Prize not specifically mentioned herein are solely the responsibility of the Verified Prize Winner(s). Sponsor is not responsible for any delay or cancellation of the debate due to unforeseen circumstances, or those outside of Sponsor's control. If the debate is canceled, the Prize will not be fulfilled, and no additional compensation will be provided. If any required documents are not timely received by Sponsor and/or Administrator, as applicable, or if any message, email or mail intended for a Potential Prize Winner(s) is not received for any reason or is returned as undeliverable, then the applicable Prize may be forfeited and go unawarded.

**7) General Rules / Limitations of Liability:** By participating in the Sweepstakes, Participants agree to be bound by these Official Rules and the decisions of the Sponsor which shall be final in all respects. Participation in the Sweepstakes constitutes permission for the Sponsor and its designees to use the Participant's name, likeness, voice, biographical information, prize information, quotes attributable to Participant, and any other elements of Participant's persona for purposes of advertising and trade in any and all media now known or otherwise developed without further compensation or review, including a Participant list to be used by Fooji and its partners to re-target participants via email or the Fooji app, unless prohibited by law. By entering the Sweepstakes, Participants authorize Fooji or their fulfillment partners to send text messages or phone calls notifying Participants of delivery details for their Prize. Participants agree that Fooji or the fulfillment partner may send the notice to the telephone number the Participant provides during the registration process, and Participants understand notifications will be sent using automatic dialing technology. Participants understand that they are not required to agree to receive such messages as a condition of participation. Fox News is not responsible for the administration of the Sweepstakes, the selection of or communications with winners, and

or any subsequent use by Fooji of the personal information Participants submit in connection with the Sweepstakes. In the event there is a discrepancy or inconsistency between disclosures or other statements (in any and all media) contained in any Sweepstakes materials and the terms and conditions of the Official Rules, the Official Rules shall prevail, govern and control. Sponsor and the other Sweepstakes Entities assume no responsibility or liability for (a) any incorrect or inaccurate entry information, or for any faulty, failed, garbled or jumbled electronic data transmissions; (b) any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of this Sweepstakes; (c) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, satellites, servers, computers, software or providers utilized in any aspect of the operation of the Sweepstakes; (d) inaccessibility or unavailability of the Internet or any combination thereof, or; (e) any injury or damage to Participant's or to any other person's computer which may be related to or resulting from any attempt to participate in the Sweepstakes. The Sponsor and other Sweepstakes Entities are not responsible for the failure of any order to be received for any reason or for any delay in the processing or failure to process any order or entries. The Sponsor reserves the right at its sole discretion to disqualify any individual that tampers or attempts to tamper with the order process or the operation of the Sweepstakes; violates the Official Rules; is suspected of cheating, fraud, or acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. Any Participant who uses or is suspected of using cheating, fraudulent means, unauthorized ordering methods, or otherwise attempts to participate multiple times, or with multiple identities, and/or addresses will be disqualified. Any attempt by any person to undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. The Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that or any other provision. If, for any reason, the Sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of the Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes, then the Sponsor reserves the right in its sole discretion to cancel, modify, suspend or terminate the Sweepstakes in whole or in part. In the event Sponsor experiences a technical failure during admission of the Sweepstakes that causes the Sweepstakes to be suspended, Sponsor shall select a winner(s) by random drawing from all valid entries received up to the point of the technical failure. **TO THE FULLEST EXTENT PERMITTED BY LAW, AS A CONDITION OF ENTRY INTO THE SWEEPSTAKES, ALL PARTICIPANTS AGREE TO RELEASE, INDEMNIFY AND HOLD HARMLESS THE SPONSOR AND OTHER SWEEPSTAKES ENTITIES FROM AND AGAINST ANY AND ALL LIABILITY, CLAIMS OR ACTIONS OF ANY KIND WHATSOEVER FOR INJURIES, DAMAGES, OR LOSSES TO PERSONS OR PROPERTY WHICH MAY BE SUSTAINED IN CONNECTION WITH: PARTICIPATING IN ANY ASPECT OF THE SWEEPSTAKES; THE RECEIPT, OWNERSHIP OR USE OF ANY PRIZE AWARDED; PREPARING FOR, PARTICIPATING IN OR TRAVELING TO AND/OR FROM ANY PRIZE- RELATED OR SWEEPSTAKES-RELATED ACTIVITY, OR; ANY TYPOGRAPHICAL OR OTHER ERROR IN THESE OFFICIAL RULES OR ANY CTA POSTS OR OTHER ANNOUNCEMENTS RELATING TO THE SWEEPSTAKES. THE**

**WINNERS SHALL BEAR ALL RISK OF LOSS OR DAMAGE TO THEIR PRIZE AFTER THEY HAVE BEEN DELIVERED. SPONSOR AND THE OTHER SWEEPSTAKES ENTITIES MAKE NO REPRESENTATIONS OR WARRANTIES OF ANY KIND CONCERNING THE APPEARANCE, SAFETY OR PERFORMANCE OF ANY PRIZE(S).**

BY ENTERING THE SWEEPSTAKES, PARTICIPANT AGREES THAT, TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW: (1) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE SWEEPSTAKES, OR ANY PRIZE(S) AWARDED WILL BE LIMITED TO ACTUAL, OUT-OF-POCKET COSTS INCURRED (IF ANY) NOT TO EXCEED TEN DOLLARS (\$10.00), BUT IN NO EVENT WILL ATTORNEYS' FEES BE AWARDED OR RECOVERABLE; AND (2) UNDER NO CIRCUMSTANCES WILL ANY PARTICIPANT BE PERMITTED TO OBTAIN ANY AWARD FOR, AND PARTICIPANT HEREBY KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES (OTHER THAN ACTUAL OUT-OF-POCKET EXPENSES NOT TO EXCEED TEN DOLLARS (\$10.00)) AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED. SOME JURISDICTIONS DO NOT ALLOW THE FOREGOING LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

Without limiting any other provision in these Official Rules, the Sweepstakes Entities are not responsible or liable to any Participant or winner (or any person claiming through such Participant or winner) for failure to supply the prize or any part thereof in the event that any of the Sweepstakes activities or Sweepstakes Entities' operations or activities are affected by any cause or event beyond the sole and reasonable control of the applicable Sweepstakes Entity (as determined by Sponsor in its sole discretion), including, without limitation, by reason of any acts of God, equipment failure, threatened or actual terrorist acts, air raid, act of public enemy, war (declared or undeclared), civil disturbance, insurrection, riot, epidemic, pandemic, fire, explosion, earthquake, flood, hurricane, unusually severe weather, blackout, embargo, labor dispute or strike (whether legal or illegal), labor or material shortage, transportation interruption of any kind, work slow-down, any law, rule, regulation, action, order, or request adopted, taken, or made by any governmental or quasi-governmental entity (whether or not such governmental act proves to be invalid), or any other cause, whether or not specifically mentioned above.

EACH PARTICIPANT UNDERSTANDS AND AGREES THAT ALL RIGHTS UNDER SECTION 1542 OF THE CIVIL CODE OF CALIFORNIA AND ANY SIMILAR LAW OF ANY STATE OR TERRITORY OF THE UNITED STATES ARE HEREBY EXPRESSLY WAIVED BY HIM/HER AGAINST THE SWEEPSTAKES ENTITIES. SECTION 1542 READS AS FOLLOWS:

*"CERTAIN CLAIMS NOT AFFECTED BY A GENERAL RELEASE. A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE, AND THAT IF KNOWN BY HIM OR HER WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY."*

**8) Privacy Policy:** By entering the Sweepstakes, Participants agree that Fooji's use of personal information submitted by Participants will be subject to Fooji's privacy policy posted at <https://www.fooji.com/privacy/> and Fox News's use of such information will be subject to Fox News Network, LLC's Privacy Policy posted at <https://nation.foxnews.com/article/privacy-policy-5bb2b1c05245a00019050118/>.

**9) BINDING ARBITRATION AGREEMENT AND CLASS ACTION WAIVER:** Except where prohibited by law, as a condition of participating in this Sweepstakes, each Participant agrees as follows:

**Binding Arbitration Agreement.** Except as otherwise stated below, any and all legal issue, claim or dispute arising out of or connected or related in any way to the Sweepstakes, including but not limited to Prize awarded, shall be resolved through final, binding arbitration. Participant specifically agrees that, except as otherwise provided herein, entry into the Sweepstakes waives all rights to bring a lawsuit based on such claim(s) or dispute(s) and the right to have such lawsuit resolved by a judge or a jury.

This Arbitration Agreement shall be governed by the Federal Arbitration Act, (9 U.S.C. § 1 *et seq.*). Any arbitration will be commenced and administered by JAMS under the rules of JAMS, including JAMS Consumer Arbitration Minimum Standards <https://www.jamsadr.com/consumer-minimum-standards/>. If JAMS' criteria are met by the nature of the dispute, the Participant agrees that the arbitration shall be conducted under JAMS Streamlined Arbitration Rules & Procedures <https://www.jamsadr.com/rules-streamlined-arbitration/>. Judgment upon any arbitration award may be entered in any court of appropriate jurisdiction.

Each party will pay the fees for his/her or its own attorneys, subject to any remedies to which that party may later be entitled under applicable law. However, if Participant is unable to pay JAMS' costs, Sponsor will pay all arbitration fees and expenses. If JAMS is unavailable, unwilling, or otherwise unable to administer an arbitration in accordance with these rules, then another arbitration administrator will do, to be selected by agreement of the parties.

**Neither Participant nor Sponsor shall be permitted to obtain awards, and all parties hereby waive all rights to claim, punitive, incidental or consequential damages, or any other damages, including attorneys' fees, other than Participant's actual out-of-pocket expenses (i.e., costs associated with participating in this Sweepstakes). The parties further waive all rights to have damages multiplied or increased.**

The arbitrator has the same authority to award relief on an individual basis that a judge in a court of law would have. The award of the arbitrator is final and binding upon both you and us. Additionally, the arbitrator, and not any federal, state, or local court or agency, shall have the exclusive authority to resolve any dispute relating to the interpretation, applicability, enforceability, or formation of this Arbitration Agreement, except that this sentence shall not apply to the Class Action Waiver provisions described below. The arbitrator will render a decision in writing. A court of competent jurisdiction shall have the authority to enter judgment upon the arbitrator's decision/award. This Arbitration Agreement will survive the termination of your relationship with us.

**Excluded Disputes.** Notwithstanding the binding arbitration requirement set forth in this section, Participant may bring qualifying claims in small claims court so long as the matter remains in such court and advances only on an individual, non-class, non-representative basis.

**Class Action Waiver.** To fullest extent permitted by applicable law, you and we agree to bring any claim or dispute, whether in arbitration, or court as permitted by these terms, ON AN INDIVIDUAL BASIS ONLY, AND NOT AS A CLASS ACTION OR COLLECTIVE ACTION. There shall be no right or authority for any claim or dispute to be brought, heard or arbitrated as a class or collective action ("Class Action Waiver"). The arbitration will decide the rights and liabilities, if any, of you and us. The arbitration proceeding will not be consolidated with any other matters or joined with any other cases or parties. The arbitrator may award any remedy to which a party is entitled under applicable law, but remedies shall be limited to those that would be available to a party in their individual capacity. Regardless of anything else in this Arbitration Agreement and/or the applicable JAMS rules, the interpretation, applicability, enforceability or formation of the Class Action Waiver may only be determined by a court and not an arbitrator. This Class-Action Waiver will survive the termination of your relationship with us.

**One-Year Time Limit to Raise Disputes or Claims.** You agree that any dispute, claim or lawsuit, regardless of form, that may arise out of or related to the Sweepstakes, must be filed within ONE (1) YEAR of the action, omission, event or occurrence giving rise to the dispute, claim(s) or lawsuit. After the expiration of the one-year period, such dispute, claim(s) or lawsuit will be time-barred and prohibited, without regard to any longer period of time which may be provided by any period of limitation or pursuant to law or statute.

**Waiver of Jury Trial.** BOTH PARTICIPANT AND SPONSOR HEREBY WAIVE ANY CONSTITUTIONAL AND STATUTORY RIGHTS TO SUE IN COURT AND HAVE A TRIAL IN FRONT OF A JUDGE OR A JURY, except as provided herein. We are instead mutually electing that all disputes, claims, or requests for relief shall be resolved by arbitration under this Arbitration Agreement, except as specified herein. An arbitrator can award on an individual basis the same damages and relief as a court and must follow this Agreement as a court would. However, there is no judge or jury in arbitration, and court review of an arbitration award is subject to very limited review.

**Location of Arbitration.** Participant may choose to have the arbitration conducted by video conference technology such as zoom, or based on written submissions. Otherwise, the location of the arbitration proceeding shall take place in the city or state where Participant resides, unless each party to the arbitration agrees otherwise, or at another mutually agreed upon location.
